

VALUES FLYER SUBSCRIPTION CONTEST – RULES

1. Contest begins at 12:01 a.m. on August 1, 2022, and ends at 11:59 p.m. on September 30, 2022 (“**Contest Period**”). This contest is conducted by Brandt Tractor Ltd. (“**Brandt**”).

2. **No purchase is necessary.** To obtain an entry form for the Values Flyer Subscription Contest (the “**Contest**”), Eligible Subscribers (defined below) simply visit:

and fully complete the form (including the skill testing question) and submit it. To be eligible, participants must be subscribers to Brandt’s Values Flyer mailing list during the Contest Period (“**Eligible Subscribers**”), and their completed entry forms must be received during the Contest Period.
