

Brandt Agricultural Products

Standard Product Warranty

Brandt Agricultural Products ("Brandt") warrants that all Brandt manufactured equipment, parts or attachments ("Brandt Product") and agricultural machinery will be of merchantable quality and free from defects in material and workmanship during the applicable Warranty period listed below. The obligation of Brandt under product Warranty coverage is expressly limited to the repair or replacement, at Brandt's option, of the defect part (s) and does not include the replacement of the complete product.

Warranty Coverage under Brandt Agricultural Products ("Brandt") is limited to product failures which are a result of defects in workmanship or material only.

Standard Base Warranty

The Standard Base Warranty period for any new Brandt Product shall be twelve (12) months commencing on the date of delivery of the new Brandt Product to the original retail purchaser.

Commercial and Demo Warranty

The Commercial and Demo Warranty period for parts, equipment, machinery or attachments shall be six (6) months commencing on the date of delivery for use of commercial business operations, determined by Brandt, or where used in rental applications or hired out on commercial basis.

Parts Warranty

The Warranty period for parts purchased shall be ninety (90) days from date of retail purchase.

Extended Product Warranty

15LP+ Oil Seed Certified Conveyors – all models will receive an additional twelve (12) months of Warranty commencing on the date of delivery of the new Brandt Product to the original retail purchaser.

Warranty Exclusions

The following items are not covered under Brandt Agricultural Standard and Extended Product Warranty:

- ❖ Belt Conveyors used for oil seed (exemption will be Oilseed-Certified™ models)
- ❖ Normal wear and tear on any Brandt Product
- ❖ Freight
- ❖ Repairs performed due to customer demand or temporary repairs
- ❖ Diagnostic time
- ❖ Shop Supplies – rags, tape, safety glasses, tools, oils, lubricants, fuses, spark plugs, filters, lights, coolants, degreasers, hydraulic fluid, chemical liquids and conditioners
- ❖ All travel costs for items such as towing, service calls, mileage, or transporting a unit to and from a Brandt dealership, where the Warranty service is performed, unless specifically covered by a Service Bulletin
- ❖ Costs related to work performed that has not been pre-authorized by Brandt or which does not follow the claims procedure
- ❖ Repaired or replaced Brandt Products beyond the expiration of the applicable Warranty period
- ❖ Failure to maintain the equipment, negligence, alterations, improper use of the equipment, collision or other accidents
- ❖ Vandalism or operation beyond rated capacity or specifications
- ❖ Neglect of service or improper service
- ❖ Acts of Gods and exposure to the elements
- ❖ Damages related to loss of use and/or loss of profits
- ❖ Repair for the Brandt Product other than by an authorized Brandt dealer/installer
- ❖ The use of the Brandt Product in extreme or severe duty applications (as determined by Brandt) nor applications that are not advertised through the applicable Brandt Product brochures, videos and other Brandt promotional materials and information which is used to promote or otherwise accompanying the sales of the Brandt Product
- ❖ Any delay in making the machine available after being notified of a potential problem
